# UPDATE: Stocks and Bond Yields Bounce on Tariff Details

I'll paste all the newswires below, but the short version is that Trump didn't announce anything concrete. Granted, it's still "phase 1" of "new tariffs on Chinese goods," but it seems less dire than anticipated, for now. Bottom line, he told the US Trade Office to take 15 days to get back to him with potential targets for increased tariffs. In other words, no new tariffs were announced.

Stocks moved instantly higher on the news, as did bonds. But neither have meaningfully erased the morning's movement. 10yr yields are up 3bps from previous lows, currently at 2.83%. Fannie 3.5 MSB are down roughly an eighth of a point from previous highs, but still nearly a quarter of a point higher on the day.
